# BERRIEN CAREER & TECHNICAL EDUCATION CONSORTIUM CONTRACT

WHEREAS, the school electors within the Berrien Regional Education Service Agency District have voted on and failed to approve the questions of adopting the provisions of the School Code which are designed to encourage the establishment and contracting for the operation of an area career-technical education consortium, and

WHEREAS, Section 690(3) of the School Code of 1976 authorized a combination of two or more contiguous constituent local districts to elect to establish an area career-technical education consortium where the electors have failed to approve the ballot questions set forth in Section 681(3), and

WHEREAS, said resolution cannot become effective until the same is approved by the intermediate school district and area career technical education designation is granted by the State Board of Education and

WHEREAS, the Board of Education on May 15, 2023 received the approval of the Berrien Regional Education Service Agency to establish an area career-technical education consortium as authorized by Section 690(3) of the School Code of 1976, and

WHEREAS, prior to this date, this school district caused to be published in a general circulation a notice of the district's intent to adopt this resolution, which

publication was in a form and manner prescribed by the School Board of Education in accordance with Section 690(3) of the School Code of 1976, and

WHEREAS, it is the desire of the board of education to continue to be a member of an area career-technical education consortium for students of the contiguous Local Education Agencies of Berrien County

#### NOW THEREFORE BE IT RESOLVED THAT:

- 1. This board of education hereby declare its intention to remain a part of the career-technical education consortium as authorized by Section 690(3) of the School Code of 1976, which program is to be operated for the contiguous Local Education Agencies of Berrien County
- 2. The contract for the operation of the area career-technical education consortium attached hereto is hereby approved and is made part of the resolution.
- 3. The operation of this program shall continue with the 2023-24 school year through the end of the 2043 school year.
- 4. In accordance with point five of the Consortium Contract, the board of education shall support CTE programming from its general fund as it does all other programs. Understanding the additional CTE state and federal funding is to assist with the increased costs associated with running CTE programming.
- 5. The president and secretary of this board of education are hereby authorized and directed to execute the attached contract on behalf of the district and file a signed copy of this resolution, together with a copy of the attached contract, with the Berrien RESA and the State Board of Education. The State Board of Education is hereby requested to continue the designation of the area career-technical education consortium.
- 6. All resolutions and parts of resolutions insofar as they conflict with the provisions of this resolution be and the same are hereby rescinded.
