

## BUCHANAN GREAT START READINESS PRESCHOOL PROGRAM





Buchanan Community Schools offers a *free* preschool program for a limited number of income-eligible four-year-olds. GSRP is a Michigan state-funded preschool program. Our program provides preschoolers with the best educational opportunities through a hands-on curriculum in a rich learning environment created through our certified staff, families, and community.

All applications for public school preschool opportunities in Berrien County will continue to be monitored by Berrien RESA. The Buchanan preschool programs are licensed through Michigan Licensing and Regulatory Affairs (LARA), Bureau of Community and Health Systems, and the Child Licensing Division.

#### **ELIGIBILITY**

Preschoolers must be 4 years of age by September 1, 2024 to qualify.

#### PRESCHOOL HOME VISITS

This is a mandatory State of Michigan requirement for our program. It is also a great opportunity for you and your child to meet your child's teacher and teacher assistant before school begins.

#### **BUCHANAN GSRP PRESCHOOL PROGRAM**

Our preschool program begins later than our K-12 students and will go through the end of the school year. Preschool classes begin on **Wednesday, September 4th**.

Sessions will meet Monday through Thursday, 8:40am - 3:43pm. *Preschool classes will not meet on Fridays*.

#### **ARRIVAL & DISMISSAL**

All Ottawa staff members will be able to assist your child with any problem if they know their full name. Be sure your child's backpack always has the school-issued ID tag and they are able to communicate their first and last name.

- Any adult picking up children must be listed by the parent on the child's emergency card.
- All doors lock when the tardy bell rings at 8:40 am and remain locked until the 3:43 pm dismissal. Please go to the front door and ring the doorbell to the right of the doors to enter after 8:40 am.

Students must be signed in by an adult after 8:40 am.

Our safety procedures for adult to adult transfers of children at the beginning and end of day takes a little extra time, but keeping children safe is a priority. Please read carefully and adhere to these procedures for the safety of our staff, students and families.

#### School hours are 8:40-3:43. First bell rings at 8:35 am.

- Adult staff will be available to supervise students beginning at 8:10 am.
- Adults will not be able to enter the building with children past the front office doors. You may walk your child to the front doors or drop off in the north parking lot through the car line.
- Kindergarten and first graders will line up inside the fenced playground area adjacent to the north parking lot with adult supervision. When the weather is inclement, they will wait inside.
- Be sure your child arrives at school by 8:35 am to avoid being marked tardy after 8:40 am.



Breakfast begins at 8:10 am. If you would like your child to eat breakfast at school, they should arrive no later than 8:20 am. Preschool students are served breakfast within their classrooms.

#### **CAR RIDERS**

When dropping off or picking up your child in a vehicle <u>you must use the north parking lot car line staffed by adults.</u> There will be no drop-offs or pick-ups in front of the school on either side of Ottawa Street or in the south parking lot blocking the posted fire lane. To get in the car line drive down 3rd Street towards the school. We use hang tags. These will be available at the Open House. Sometimes the line may back up into Ottawa Court, **please do not block residents' driveways.** 

#### WALKERS

Walkers will use the front entrance of the school for arrival and will be dismissed out the gym door on the south side of the building. If an adult walks their child to the front door in the morning or picks up after school, please park in the Church of the Nazarene lot. Our buses may block the entrances to the south parking lot and you will not be able to exit until the buses leave. We have permission to use this parking lot at 704 W. Front. Please walk your child to and from this lot. We encourage parents if dropping off or picking up to use the car line in the north parking lot.



No parking or drop off is permitted in the fire lane in the south parking lot.

#### **BUS RIDERS**

Bus students enter through the front doors and report to the cafeteria to eat breakfast. Those not eating breakfast will join their before-school lines as detailed previously. After school, staff will walk students in their bus lines directly to the bus they ride home. Please note, changes in your child's after-school plans for dismissal must be communicated adult to adult. Please call the office before 2:00 pm if there are transportation changes. Teachers do not always have time to check their email or messages during the day and we want to ensure your child's safety after school. Thank you for your understanding and cooperation!

#### **ARRIVAL & DISMISSAL**

- Morning car riders will be dropped off at the 5th Street door between 8:10-8:40 am. The doors lock at 8:40 am. Car riders who arrive after 8:40 am will need to enter through the Main Office door #1.
- Please drop off students on 5th Street. Students who are dropped off in the morning are to wait in the fenced-in playground area at the back of the school.
- Breakfast begins at 8:10 am. Students eating breakfast should enter through the gym doors off of 5th Street. Students will then go to the playground area when done eating.

#### **BIKE RIDERS**

Students may ride their bikes to school at Moccasin with parent permission. Bike helmets are encouraged. Bike racks are located in the back of the building near the south end off of 5th Street. Bikes must be placed in the rack. Students and parents are responsible for providing locks to ensure the safety of their bike. The school is not responsible for bikes.





#### **CAR RIDERS**

Car riders will be picked up on 5th Street on the south end of the building. 5th Street is a one-way street that is accessed off of Main Street. Pick-up and drop-off will be one lane along the sidewalk by the gym entrance.

#### **WALKERS**

Walkers will exit the middle front entrance on Moccasin Street. As Moccasin has older elementary students, they will be released to walk home at the dismissal bell. Parents do not need to come in and check them out. If your child is a walker, please ensure that they know their designated walking route to and from school (the route you expect them to walk every day).

#### **BUS RIDERS**

The loading and unloading zone for buses is along the east side of Moccasin Street directly in front of the school from 5th Street to just past the north parking lot. This area is designated as a bus loading & unloading zone only. NO car pick-up or drop-off is allowed in this zone. Please communicate your child's after school transportation plan or changes to their plan to the main office by 2:00pm.

#### P.M. SHUTTLE BUS TO MOCCASIN

Due to the age of Ottawa students coming to Moccasin via the shuttle, they will not be released from the bus until a parent or designated person comes to the bus door and accepts the child(ren). The person must be listed on the student's emergency card or approved by the school office prior to pick-up. Staff may ask the adult for an ID. If you are waiting for the shuttle, please park either before or after the bus pick-up zone on the east side of Moccasin Street (before 5th Street or after the exit for the north parking lot).

Parents and students will be able to meet the Middle School staff and have an opportunity to explore the building to locate classrooms. Students will also have the opportunity to practice their locker combinations and receive their schedules. Schedules will not be sent via mail. If you are unable to make the orientation times, your child will receive their schedule on the first day of school when we meet by grade level to begin the day.



#### **FIRST DAY OF SCHOOL**

School begins this year on Monday, August 26, 2024, with a full day of classes. The <u>front cafeteria door</u> (Door 13) will be open at 6:50 am for breakfast. If your child is not eating breakfast, the main door (Door 1) will also open at 6:50 am. Students will be placed in grade-level locations to wait for teachers to escort them to class.

Classes will begin at 7:30 am and end at 2:25 pm. Students should be out of the building by 2:40 pm unless, of course, they are staying for an activity. Learning punctuality is imperative for adolescents as we prepare them for their future. Please assist us in teaching our students the importance of being on time for school and **all** of their classes.

This year, as in previous school years, BMS students will receive a packet containing our school's yearly calendar, conference dates, report card dates, and other information that will keep you aware of what, when, where, and how things proceed at BMS.

Parents who drop off and pick up students before and after school are asked to do so in designated areas in front of the school (flagpole side). Please use caution driving in this area. After 7:40 am each school day, the front doors (by the flagpole) will be locked.

#### **ATHLETICS**

All students interested in participating in BMS Athletics will need to have a physical form on file with the office. New athletes can get a copy of this physical file from the main office or from the BCS Athletic website under the "Files & Links" section. The first day of mandatory practice is the first day of school, August 26, 2024.

#### BMS DROP-OFF PROCEDURES

Buses drop off students each morning in the front of the school. They use the curb directly in front of the school and are usually right on time at 6:50 am. Please do not park along that curb until after the buses leave. If no buses are present, we ask that drivers pull all the way to the end of the curb in front of the building. Students will then enter Door 1 if they are not eating breakfast, and Door 13 if they are eating breakfast. Parents should not use the parking lot for drop off unless the parent is coming into the building for a meeting or to drop something off.

#### **BMS PICK-UP PROCEDURES**

Buses will load in the back of the school. Once all students are loaded on the buses, the buses will leave the back drive.

ORIVERS MUST YIELD FOR BUSES AS THEY DEPART!

Just as in the morning, we ask that drivers pull all the way to the end of the curb in front of the school. The line can look long, but it moves quickly. All cars are usually through the line by 2:30 pm.


① At dismissal, parking in the church parking lot and having students cross 4th Street is <u>not</u> a safe practice. There is a police officer there to help with traffic, but this is <u>NOT</u> a crosswalk location. Students needing to cross 4th Street will need to walk to the stop sign at Chippewa Street and cross there.





#### **BUCK PRIDE**

At BMS our students are encouraged to exhibit their school **PRIDE** on a daily basis. School **PRIDE** consists of being **P**repared for class, **R**esponsible and respectful, having **I**ntegrity, **D**edicated to learning, and putting forth their best **E**ffort. BMS has a school-wide PRIDE program



that recognizes our students for doing a great job in creating a learning environment that is safe, caring, and develops successful and responsible citizens.



#### **DRESS CODE**

Students are expected to dress appropriately for school. The responsibility for student dress is that of the students and the parents. The following guidelines should be followed:

#### Pants/Shorts/Dresses/Skirts:

- Jeans, Pants, Leggings, and Joggers.
- Shorts, Dresses, or Skirts should provide modest coverage of the backside.
- Leggings, spandex, and biker shorts must be opaque and not see-through.
- Pants/shorts with holes should not have any holes with skin showing above fingertip length.
- No pajamas of any kind.
- Pants and shorts are to be worn at the waist. Sagging is not acceptable.

#### **Shirts:**

- Tank top straps must be 3 inches in width.
- No shirts showing midriff.
- No muscle shirts.
- Appropriate necklines should be observed.
- No shirts with inappropriate slogans or advertisements.
- Winter jackets should be kept in lockers at all times.

#### Hair:

- Students may dye their hair whatever color parents allow as long as it does not cause a major disruption to the learning environment.
- No bandanas.
- No hats inside the building.

#### Footwear:

• Shoes or sandals must be worn at all times.

#### All school bags are to be kept in lockers and not carried to class.

If a student is in violation of the dress code, they will be asked to change or call for a change of clothing. If no change of clothing is available, they may be placed in the learning center for the day.

The administration reserves the right to make a final judgment concerning the appropriateness of a student's attire & appearance.

#### **CELL PHONE & HANDHELD DEVICE POLICY**

Cell phones, MP3 players, iPods, handheld games, etc. are not allowed on a student's person during school hours. They must be turned off before the first bell and kept in the student's locker. If a student is found in possession of a device, it will be confiscated and sent to the office. The first incident will come with a warning and a phone call home. Any other incident will require a parent or guardian to pick up the device in the school office. Disciplinary action will be taken for students not complying with this expectation. Students needing to get in contact with parents during school hours may use a school phone with faculty or staff approval.

School Improvement is a continuous process and BHS works year-round to make our school a better place to learn, grow, and prepare for the future. If you are interested in joining our conversations and helping with our initiatives, feel free to contact us for more information. The following are highlights of our current initiatives:

- Chromebooks for every student grades 8 through 12. Teachers continue to expand opportunities to use technology as a method to engage and promote student learning. Chromebooks are a required device during the school day. Device Protection Plans are available. Students are expected to have their assigned Chromebook along with their chargers with them in all classes.
- Professional Development opportunities for teachers that
  focus on making students the center of our conversations as
  we track academic growth and improve the culture and
  climate of our school. Teachers will also be trained in using
  new technology platforms and programs as those areas
  continue to change, evolve, and expand in education.
- **Virtual Learning** continues to improve with MyVirtual in our E-Lab. Credit recovery, as well as acceleration, are possible with the approval of the Principal. This platform will be used for all students who did not earn credit in their previous courses in order to keep them on track for graduation.
- **Wacky Wednesdays** will continue. Students are dismissed at 2:07 pm every Wednesday to allow weekly professional learning time for staff.
- After-School Academic Learning Sessions are once again offered Monday through Thursday.

**EIGHTH & NINTH GRADE CHROMEBOOKS** will be distristributed during the BHS Back to School Night on August 19th from 6-7:30pm.

**COMMUNITY VOLUNTEERS** are always needed and sought after. If you have a talent or skill that you would like to share with us, please reach out to the Principal's Office at 269-695-8403 option 1. No talents or skills are necessary however; sometimes we just need your time! All volunteers need to have a background check completed before working with students.

**THE STUDENT HANDBOOK** along with our Code of Conduct policies may be found on our school website at www.buchananschools.com in September. Policies have been composed with the goal of creating an environment that supports learning. Keep our dress code in mind when you are shopping for your child's school clothing. Students not adhering to the dress code will be sent home to change or will be given a change of clothes.

## Buchanan Community Schools operates quality special education programs in all four of our schools!

Providing programs and services in Buchanan to eligible students are nine specially trained and certified special education teachers, thirteen para-professionals, and three speech and language pathologists. Support also comes from the following staff members from Berrien RESA (Regional Education Service Agency): school psychologist, school social worker, academic teacher consultant, mobility specialist, assistive technology specialist, teacher consultants of the visually impaired and the hearing impaired, occupational and physical therapists. Students are placed in programs through an Individual Educational Program Planning Committee meeting composed of local district and Berrien RESA diagnostic and educational staff once appropriate assessments have been administered and the student qualifies under Michigan special education rules and regulations. Nearly 230 PK-12 students receive some kind of special education services including speech and language during the school day in Buchanan.

Our special education programs serve a wide variety of eligible students with special educational needs in the following areas:

- Early Childhood Developmental Delay (ages 3-8)
- Specific Learning Disability, determined by a process of analyzing the student's pattern of learning strengths and weaknesses.
- Speech and Language Impaired for Language, Articulation/Phonology, Voice, and Fluency (stuttering) concerns

- Emotionally Impaired
- Cognitive Impairment
- Autistic Spectrum Disorder
- Traumatic Spectrum Disorder
- Otherwise Health Impaired
- Physically Impaired
- Hearing Impaired
- Visually Impaired

Some students need programs that are not offered within the district. The IEP process is used to make this determination and to place these students in programs that offer the services necessary to meet their goals and objectives. Transportation is provided for these students.

An additional 30 students rece<mark>ive services in center-based programs operated by Berrien RESA throughout the county including a cooperative inter-agency program for 0 - 2.5 year-olds in the Early On programs (269-471-7725) for infants and toddlers involving both parent and child.</mark>

#### Other center-based programs funded by Berrien RESA include:

- Berrien Springs Hearing Impaired Program provides services for students in the tri-county area. This program is operated by the Berrien Springs Public Schools. Students may attend a classroom program for the hearing impaired in Berrien Springs or may get teacher consultant services in their Buchanan classes. This program also provides on-site hearing diagnostic assessments with trained audiologists as well as follow-up with students who have suspected or verified hearing losses.
- Low-incidence special education programs for the cognitively impaired children who need full-time placements are available at Berrien Springs MS and HS, as well as Howard School in Niles and the Southside School Pre-vocational studies program for ages 16-25 in Niles. These students have below-average abilities and graduate with a certificate of completion. The curriculum focuses on independent living and employability skills.
- Blossomland Learning Center programs in Berrien Springs serve our moderate to severe cognitively impaired and severely multiply impaired students ages 3-26. The school assists students in preparing for entry into their respective communities as adults.
- Lighthouse Education Center in St. Joseph as well as Ballard and Southside Schools in Niles offer support to students with severe emotional impairments. These students exhibit a severity of emotional difficulties, which prohibits them from attendance in regular classrooms. Additionally, students may attend Lighthouse if they have severe autistic impairments.

All special education programs and services follow the rules and regulations for eligibility set forth by the State of Michigan's Department of Education. #### **GRADES 5-12**

Buchanan Virtual Academy offers full-time online opportunities for students in grades 5-12. Coursework is done from home and the curriculum is available 24/7 with certified teachers available six days a week. The engaging curriculum offers flexibility and covers all Michigan requirements. Students may accelerate at their own individual pace.

High School courses meet the Michigan Merit Curriculum requirements and 18 credits are required for graduation. Students enrolling with previous high school credits will have their credits examined and credited in the Michigan Merit requirements where possible.

Buchanan Virtual Academy focuses on student mastery of content and all courses are attached to Michigan-certified teachers offering students academic assistance along the way. Progress reports are available for parents as well as communication with students by phone, email, instant and text messaging, and video conferencing. If needed, students are provided a computer and internet access free of charge.

Students who live in the Buchanan school district are eligible for enrollment as well as all Berrien County students and students in adjacent counties.

Online learning is a fit for many students unable to take classes in a traditional setting. 



## Safely transporting students to a foundation of lifelong learning and working together as a team to provide safe and successful transportation services

#### **GENERAL RULES FOR TRANSPORTATION**

- Be on time at your designated bus stop. Drivers have a schedule to meet and cannot wait for tardy pupils. If the bus cancels its lights or pulls away, DO NOT CHASE THE BUS. This is how accidents happen.
- Cheerfully obey the bus driver's instructions. Friendly, respectful people get along better.
- Students are expected to display good behavior while on the bus. Quiet conversation is fine. When approaching a railroad crossing, students are to be silent until the bus is safe across the tracks.
- Always remain seated while a bus is moving. It may be necessary to sit three to a seat. The driver may also assign seats.
- Wait until the bus has come to a complete stop before attempting to enter or leave the bus.
- Eating or drinking is not permitted on the buses except for special occasions approved by the driver.
- Students are expected to help keep the buses clean. Dispose of paper and other unwanted items properly.
- Musical instruments, books, projects, or other personal items must be held by the owner or placed in a special seat designated by the driver if the room is available. We encourage parents to transport on days large items must be taken to school.
- Stay off the roadways at all times while waiting for a bus. Form a single line and board the bus one at a time. Remember to respect the property of others while waiting for the bus.
- Hands and heads are to be kept inside the bus at all times. There will be no unnecessary disturbing noises or vulgar/profane language.
- Students are expected to get on and off the bus at their designated stops ONLY. A parent/guardian must contact the school office directly, either by phone or by sending a note with their student. Please include the date, name, and address of where your child needs to be dropped off. The drivers will NOT ACCEPT notes, text messages, or phone calls from a parent on the student's cell phone while loading at the school. A bus pass must be issued through the office. NO EXCEPTIONS!
- When crossing, students must be 10 ft. in front of the bus, stop and look at the driver. When the driver gives a sweeping motion of their hand, students may then cross only in front of the bus. NEVER should a student cross the road behind the bus.
- Animals, glass containers, and helium balloons are not allowed on the buses.
- Students are asked to report any damage they see to the driver. Vandalism is a serious issue and will be addressed as soon as possible.
- Riders are expected to be considerate to all other passengers and to the driver at all times.
- Misconduct on the bus will not be tolerated. Drivers are in charge at all times and are required to report this behavior to the building principals. Riding privileges may be suspended.
- Per Michigan State Law, adults are not allowed to board school buses unless invited.
- Remember...school bus transportation is a privilege, not a right. Misconduct may result in the loss of this privilege.



#### RESPONSIBILITY OF PARENTS

- Review bus riding rules with your child.
- Be sure your child arrives at their stop 5-10 minutes prior to bus arrival.
- Provide necessary protection for your child at the stop.
- Accept the responsibility for your child's conduct at the bus stop and on the school bus. Remember: "Adults set the example and mood for their children."

Additionally, we are pleased to introduce Tre' Myers, who will be joining us as a substitute driver. Tre' will undergo training over the summer and will be ready to start when we return from summer break.

In July, parents and guardians will receive an email asking for transportation requests for the fall. Please look out for this email to ensure we have the correct contact information for your child and their pick-up and drop-off locations.



## MARK KURLAND

#### DIRECTOR OF OPERATIONS AND INSTRUCTIONAL SYSTEMS COORDINATOR

The Operations Department consists of maintenance and custodial services. The custodial services are a combination of Buchanan employees as well as a third party company, Enviro-Clean. This is the second year that we have shared custodial services with Enviro-Clean due to staff shortages. Maintenance covers all repairs for the district including heating, air conditioning, plumbing, and electrical. Over the past school year:

I. Ottawa elementary installed two boilers that service 10 classrooms and include new univentilaters that are in each classroom (A-C)







II. Buchanan High School Competition Gym installed new LED lights as part of a sinking fund project (D) and we fixed two sink holes at the football field and track area (E)









III. Moccasin and Ottawa have both had a washer and dryer system added to the building to support custodial services. This includes plumbing and electrical (F). The Moccasin Boiler also had new tubes installed to increase the lifespan (G)

## BECKY KALTENBACH FOOD SERVICE

The Food Service staff carefully plans and serves meals to meet the nutritional requirements of the age group at each school. We continually work to provide meals that are not only nutritious, but also appealing to students. We do this by including a wide variety of fruits and vegetables, as well as time-tested kid favorites like pizza and chicken nuggets. This year we were very pleased to join other school districts across Michigan in offering *free* breakfasts and lunches to all BCS students. This was great for the kids, parents, and staff! On average, we served about 464 student breakfasts and 1,071 lunches each day. Other highlights of the year include:

- Working with student volunteers and Buchanan High School Art Teacher Sandra Miller, we designed and painted a mural in the High School cafeteria.
- We purchased new cafeteria seating for the high school, including BCS branded tables and cafe-height counters with chairs.
- Ottawa Elementary now has a new, larger walk in freezer which has helped with the increased meal counts there.
- For the first time, we have a commercial dishwasher for the high school kitchen. This has allowed us to begin using reusable trays, greatly reducing the amount of styrofoam going to the landfill.





The Information Technologies Department at Buchanan Community Schools is responsible for the maintenance of all technologies used in the education of students and the support of that education. This includes obvious things such as teacher and student computers, projectors, Chromebooks, wifi, etc., but also includes the network infrastructure connecting our buildings together.

#### **Buchanan High School Security Cameras**

Through a combination of special security funds and donations, the security camera systems at BHS were significantly upgraded. The extremely old and oddly shaped buildings provide many challenges for placing cameras so that all important areas have adequate coverage. In order to properly monitor and secure the main BHS campus, over 200 indoor and outdoor cameras were installed.

#### Network Equipment Upgrades (10 Gbps backbone)

Taking advantage of federal eRate dollars, the primary Internet and fiber optic connection into the District was increased to 3Gbps which allows for us to set aside a dedicated 1Gbps to each of three connecting buildings with services originating at BHS. To provide this much more robust network, the equipment at BHS was upgraded to support 10Gbps. This year was a trial run for a much less expensive brand and type of equipment. The positive results have given us the confidence to move forward with similar upgrades at Buchanan Middle School, Moccasin and Ottawa over the next two years.

#### **Elementary IFP Chromeboxes**

Completing the classroom hardware upgrades started a few years ago, this year we added a Chromebox computer to each of our elementary Interactive Flat Panels (IFP) complete with wireless mouse and keyboard. This addition provides a dedicated computing device for the panel which frees the teacher's computer up for other work while students are engaged with the IFP. This also significantly extends the abilities of the IFP to include student login, full Google Workspace integration and support of the Google Play store to add educational and classroom apps.

#### **Buchanan Middle School Computer Lab Upgrades**

Before school started in the fall of 2023, we were able to complete a series of key hardware upgrades to the student workstations in the BMS computer lab. At a savings of 80% over total replacement, we were able to extend the life of the equipment for another three to four years while simultaneously increasing the systems' capabilities.

#### **NOTIFICATION OF ASBESTOS REINSPECTIONS**

To: Parents & Staff of Buchanan Community Schools From: Mark Kurland, Director of Operations & Instructional Systems Coordinator Date: July 2024

In compliance with the 1989 U.S. Environmental Protection Agency (EPA) Asbestos Hazard Emergency Response Act (AHERA), we have performed inspections of each of our school buildings for asbestos-containing building materials. The inspection findings and asbestos management plans are on file in each school administrative office and in the office at Central Maintenance

The EPA requires us to perform reinspections of the asbestos materials every three years. The three-year reinspections were performed by an accredited asbestos inspector in July 2023. We perform the six-month periodic surveillance as required by the AHERA regulations.

The results of the reinspections and management plans are on file in each school's administrative office and Business Office. Everyone is welcome to view these at any time during normal hours (M-F 8:00 a.m. - 4:00 p.m.). I will be available at 695-8400 to answer any questions you may have about asbestos in our buildings.

#### NOTICE OF NONDISCRIMINATION IN EDUCATION AND EMPLOYMENT

Buchanan Community Schools complies with all federal laws and regulations prohibiting discrimination and with all requirements and regulations of the U.S. Department of Education. #### **DIRECTORY INFORMATION ON STUDENTS & FERPA**

In compliance with Federal regulations, the Buchanan School District has established the following guidance concerning student records:

- The building principal is the Records Control Officer for the building and is responsible for the processing and maintenance of all student records.
- Each student's records will be kept in a confidential file. The information in a student's record file will be available for review only by the parents or legal guardian of a student, adult student (18 yrs. of age or older), and those designated by Federal law of District regulations.
- A parent, guardian, or adult student has the right to request a change or addition to a student's records and to either obtain a hearing with District officials or file a complaint with the U.S. Office of Education if not satisfied with the accuracy of the records, or with the District's compliance with the Federal Education Rights Privacy Act (FERPA).

- The District has established the following information about each student as "directory information" and will make it available upon a legitimate request unless a parent, guardian, or adult student notifies the school principal in writing within ten (10) days from the date of this notification that they will not permit distribution of any or all such information: student name, address, telephone number, date and place of birth, photograph, participation in officially recognized activities and sports, height and weight of athletic team members, dates of attendance, date of graduation and awards received, and any other information the District considers would not be harmful or an invasion of privacy if disclosed.

#### **ANTI-BULLYING**

All types of bullying, including cyberbullying, without regard to subject matter or motivation are prohibited.

#### PARENT NOTIFICATION REGARDING SEX EDUCATION AND AIDS CLASSES

The Board of Education has adopted a comprehensive Health Education Program which includes education on human sexuality and venereal and non-casual-contact communicable diseases such as AIDS. It is designed to provide an appropriate means for students to acquire the knowledge, skill, and attitudes necessary to maintain good health.

In compliance with State law and with its desire to maintain effective communication with parents and the community, the Board has made arrangements for the programs and instructional materials to be available for review by any parents or interested members of the community. If you wish to review any or all of the programs, please contact the principal of your child's school. After reviewing the programs, if you wish to discuss them, please contact the principal or the school office. Your child is required to participate in these courses, but the law allows you the right to have your child excused from participating in classes that include instruction in sex education, reproductive health, family planning, and AIDS education. The Board's policy is to honor parents' written requests that their child be excused from certain classes in any course. We encourage you to personally review the program lessons and materials.

#### PROTECT YOUR CHILD FROM MENINGOCOCCAL DISEASE AND OTHER SERIOUS ILLNESSES THAT CAN AFFECT PRE-TEENS

Pre-teens and adolescents need vaccines to protect them from serious illnesses. Immunizations begin at birth and continue throughout life. These shots are an important step to maintain your child's health.

Meningococcal disease is a serious illness caused by bacteria that infects the blood or tissues around the brain and spinal cord.

- This germ can be spread from person to person by close contact.
- Common symptoms include a fever, rash, headache, or stiff neck.
- · It can lead to brain damage, disability, and death.
- Meningococcal vaccine (MCV4) can protect children and adolescents from this disease.
- This vaccine is usually given to 11-12-year-olds (6th graders).
- Because it is a newer vaccine, older adolescents may not have received it. Teens that have not had Meningococcal vaccine should be given a dose.
- Ask your child's health care provider if they need the Meningococcal vaccine.

To obtain the Meningococcal vaccine and other immunizations for your child, see your child's health care provider or your local health department.

For more information about the Meningococcal vaccine or other immunizations, talk to your child's health care provider or call your local health department. Information is also available at the Center for Disease Control and Prevention (CDC) website: <a href="https://www.cdc.gov/vaccines">www.cdc.gov/vaccines</a>.

There are vaccines that can protect pre-teens and adolescents from other serious diseases. Sixth graders and teens need the following shots if they have not received them:

- 1 dose of meningococcal vaccine (MCV4)
- 1 dose of diphtheria, tetanus, pertussis vaccine (DTP, DTaP, Tdap)
- 3 doses of human papillomavirus vaccine (HPV4 for girls only)
- 3 doses of hepatitis B vaccine (HepB)
- 2 doses of measles, mumps, rubella vaccine (MMR)
- 2 doses of chicken pox vaccine (var), if they did not have the disease
- At least 3 doses of polio vaccine (IPV or OPV)
- Some children & teens may need hepatitis A and flu vaccine

The Michigan Department of Education in cooperation with the Michigan Department of Community Health is required by law (2005 PA240, MCL380.1177a) to develop and make available to schools information on Meningococcal Meningitis.

#### **CONCUSSION AWARENESS**

A student cannot participate in a school-sponsored or operated athletic activity until the student and their parent have each received and read the concussion fact sheet for students and the concussion fact sheet for parents, respectively. Both the student and parent must sign and return a form acknowledging receipt of the fact sheet or other concussion awareness educational material. At a minimum, schools must keep these acknowledgment forms in a permanent file as long as the student participates in a school-sponsored athletic activity.

#### MEMORANDUM TO PARENTS REGARDING SCHOOL BOARD POLICY ON DRUG-FREE SCHOOLS & USE OF DETECTION DOGS

In accordance with Federal Law, the Board of Education prohibits the use, possession, concealment, or distribution of drugs by students on school grounds, in school or school-approved vehicles, or at any school-related event. Drugs include any alcoholic beverage, anabolic steroid, dangerous controlled substance as defined by State statute or substance that could be considered a "look-alike" controlled substance. Compliance with this policy is mandatory for all students. Any student who violates this policy will be subject to disciplinary action, in accordance with due process and as specified in the student handbook, up to and including expulsion from school. When required by State laws, the District will also notify law enforcement officials. The District is concerned about any student who is a victim of alcohol or drug abuse and will facilitate the process by which they receive help through programs and services available in the community. Students and their parents should contact the school principal or counseling office whenever such help is needed. The District may use a detection dog, without a warrant or consent, to sniff property in an effort to locate illegal drugs or contraband according to the protocol in policy 3107. If a detection dog alerts on a person's property, the alert will constitute reasonable suspicion for a District administrator to search the property.

#### PARENT NOTIFICATION OF PESTICIDE SPRAY ON SCHOOL PREMISES

State of Michigan law requires schools that may apply pesticides on school property to provide an annual advisory to parents or guardians or students attending the facility.

Please be advised that Buchanan Community Schools utilizes an Integrated Pest Management (IPM) approach to control pests. IPM is a pest management system that utilizes all suitable techniques in a total pest management system with the intent of preventing pests from reaching unacceptable levels or reducing an existing population to an acceptable level. Pest management techniques emphasize sanitation, pest exclusion, and biological controls. One of the objectives of using an IPM approach is to reduce or eliminate the need for chemical applications of pesticides. However, certain situations may require the need for pesticides to be utilized.

As required by State of Michigan law, you will receive advance notice regarding the nonemergency application of a pesticide such as an insecticide, fungicide or herbicide, other than a bait or gel formulation, that is made to the school grounds or buildings during this school year. In certain emergencies, such as an infestation of stinging insects, pesticides may be applied without prior notice to prevent injury to students, but you will be notified following any such application.

Application of pesticides will be performed only by certified or registered applicators where and when required. If a pesticide is applied in a building, students will not occupy the room for a minimum of four hours. At the time of application, a sign will be posted for 48 hours near the building's primary point of entry. When a pesticide is applied to school district grounds, the application will not be made within 100 feet of occupied classrooms, and flags will be inserted in the ground to mark the application area.

Advance notification of pesticide applications, other than a bait or gel formulation, will be given by 2 methods. The first method will be by posting at the main entrance of the school to which the pesticide application is being made. The second method will be by posting on the school's website at www.buchananschools.com.

Please be advised that parents or guardians of children attending the school are entitled to receive the advance notice of a pesticide application, other than a bait or gel formulation, by first-class United States mail postmarked at least 3 days before the pesticide application, if they so request. If you prefer to receive the notification by first-class mail, please contact Mark Kurland, Director of Operations & Instructional Systems Coordinator at 269-695-8400 ext. \*20005 or mkurland@buchananschools.com.

Please be advised that parents or guardians of children attending the school may review the school's Integrated Pest Management program and records of any pesticide application upon request. #### PARENT NOTIFICATION REGARDING BLOODBORNE PATHOGENS

Buchanan Community Schools is subject to regulations from OSHA to restrict the spread of hepatitis B virus (HBV) and human immunodeficiency virus (HIV) in the workplace. These regulations are designed to protect employees of the District who are, or could be exposed, to blood or other contaminated bodily fluids while performing their job duties.

Because of the very serious consequences of contracting HBV or HIV, the District requests the person who was bleeding consent to be tested for HBV and HIV. This information would then be provided both to the exposed employee and the treating physician to determine proper medical treatment.

The law does not require parents or guardians to grant permission for the examination of their child's blood, but it does require the District to request that consent. Although we expect that incidents of exposure will be few, we wanted to notify parents of these requirements ahead of time. That way, if the situation does develop you will understand the reason for our request and will have had an opportunity to consider it in advance. These are serious diseases, and we sincerely hope that through proper precautions and cooperation we can prevent them from spreading. #### PROTECTION OF PUPIL RIGHTS AND PARENTAL ACCESS TO INFORMATION

The Board of Education respects the privacy right of parents and their children (policy 5308). No student shall be required as a part of the school program or the District's curriculum without the prior written consent of the student, (if an adult or an emancipated minor) or, if an unemancipated minor, their parents, to submit to or participate in any survey, analysis, or evaluation that reveals information concerning:

- political affiliations or beliefs of the student or their parents;
- $\bullet \quad \text{mental or physical problems of the student or their family;} \\$
- sex behavior or attitudes;
- $\bullet \quad \text{illegal, anti-social, self-incriminating, or demeaning behavior;} \\$
- critical appraisals of other individuals with whom respondents have close, family relationships;
- legally-recognized privileged and analogous relationships, such as those of lawyers, physicians, and ministers;
- religious practices, affiliations, or beliefs of the student or their parents;
- or income (other than that required by law to determine eligibility for participation in a program or for receiving financial assistance under such program).

The Superintendent shall ensure that procedures are established whereby parents may inspect any material used in conjunction with any such survey, analysis, or evaluation.

Further, parents have the right to inspect, upon request, a survey or evaluation created by a third party before the survey/evaluation is administered or distributed by the school to the student. The parent will have access to the survey/evaluation within a reasonable period of time after the request is received by the building principal.

#### PA 158, WEAPON-FREE SCHOOL ZONE LEGISLATION

Under PA 158, any person who assaults another person with less than the intent to commit murder or to inflict bodily harm, with a gun, revolver, pistol, knife, iron bar, club, brass knuckles, or other dangerous weapons in a weapon-free school zone, is guilty of a felony punishable by one or more of the following:

- Imprisonment for not more than four years
- Community service for not more than 150 hours
- A fine of not more than \$6,000.

A parent of a minor is guilty of a misdemeanor if they have custody of the minor, the minor has a weapons violation in a weapon-free school zone, and the parent knows that the minor would violate the firearms act or acts to further the violation. The misdemeanor is punishable by one or more of the following:

- Fine of not more than \$2,000
- Community service for not more than 100 hours
- Probation

The law also provides that anyone in possession of a weapon in a weapon-free school zone is guilty of a misdemeanor punishable by one or more of the following:

- Imprisonment for not more than 93 days
- Community service for not more than 100 hours
- Fine of not more than \$2,000

#### PARENTS RIGHT TO REVIEW TEACHER QUALIFICATIONS

As a parent of a student at Buchanan Community Schools, you have the right to know the professional qualifications of the classroom teachers who instruct your child. Federal law allows you to ask for certain information about your child's classroom teachers and requires us to give you this information in a timely manner if you ask for it. Specifically, you have the right to ask for the following information about each of your child's classroom teachers:

- Whether the Michigan Department of Education has licensed or qualified the teacher for the grades and subjects they teach.
- Whether the Michigan Department of Education has decided that the teacher can teach in a classroom without being licensed or qualified under state regulations because of special circumstances
- The teacher's college major; whether the teacher has any advanced degrees and, if so, the subject of the degrees.
- Whether any teachers' aides or similar paraprofessionals provide services to your child and, if they do, their qualifications.


